- For continuing “Chief Engineer, APCRDA” as one of the board member of ASSCCL in the role of “Director”; as every person employed immediately before the coming into force of this “The Andhra Pradesh Decentralization and Inclusive Development of All Regions Repeal Act’ 2021” in the AMRDA shall be deemed to be employed in the APCRDA.
- For continuing Director (Accounts), APCRDA, Chief Engineer/Director, APCRDA and Additional Commissioner, APCRDA as shareholders of ASSCCL, each with 01 no’s of shares with Rs.10/- (Rupees Ten Only) value; as every person employed immediately before the coming into force of this “The Andhra Pradesh Decentralization and Inclusive Development of All Regions Repeal Act’2021” in the AMRDA shall be deemed to be employed in the APCRDA.

2. The Managing Director & Chief Executive Officer, Amaravati Smart & Sustainable City Corporation Limited (ASSCCL), Vijayawada and the Commissioner, APCRDA, Vijayawada shall take further necessary action in the matter.
